Definitions	
Affiliates	Companies related by common ownership or control, Guidance Capital, Inc. and Dynamic Market Advantage, LLC.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
